Specific ear-marked services and capital provided by this funding included equipment for orthopedic and surgical services, infusion and rehabilitation departments, behavioral health services, home health and hospice department, and LHC's emergency response to the COVID-19 pandemic. This also included pledge payments toward the New Hospital
