A LETTER FROM OUR BOARD CHAIR

“Strange days, indeed.” The immense, global upheaval in the health care industry in response to COVID-19 has brought staggering figures of all kinds. Whether we consider the number of cases, tests, PPE, ventilators, ICU beds or tragically, the total number of those who have died as a result of this pandemic, the amounts exceed historical proportions and have brought many hospitals, especially rural hospitals, to their fiscal knees.

Despite these economic headwinds, Livingston HealthCare is still financially healthy. With this in mind, it is an honor to be associated with the donor community of Park County, upon whom Livingston HealthCare Foundation can count, to come through when they’re needed.

In fiscal year 2020, the Foundation raised **\$1,387,568** in new contributions from individuals, businesses and foundations. Along with \$116,322 from state and federal COVID-specific grants, as of June 30th, the **Emergency Response Fund level was \$290,074**. Last year’s major campaign in support of Pediatric and Adolescent Mental Health continued to receive donations into FY20 for a total raise of \$421,133, of which \$183,000 was a significant grant from AMB West Philanthropies (please see pages 9-10 for a full update). Generous giving to the Year-End Appeal for growing needs in our Infusion Department resulted in \$30,787.

A very special thanks to Dr. Debbie Erdman for her many years of service and generous support as a board member, Chair and major donor. Debbie is stepping down from the board for a year; we hope to have her back. In working with Debbie, I have come to know her as a devoted philanthropist and as a friend.

The deadline for the printer to receive all content for this annual report was July 1st, and so, circumstances surrounding COVID-19 could be very different between then and your reading this now.

Marcia received her medical degree from Columbia University after graduating summa cum laude from Mount Holyoke College in Massachusetts. She completed her internship and residency at Columbia and went on to serve as Chief of Cardiology at Stamford Hospital, a Columbia-affiliated campus in Stamford, CT, for 30 years. Among her roles was the teaching of Columbia medical students and house staff, and she was appointed a professor of Clinical Medicine at Columbia. Marcia was one of the first women in the country to be elected a Fellow of the American College of Cardiology. She is also a Fellow of the American College of Physicians, American College of Chest Physicians, and Council on Clinical Cardiology of the American Heart Association.

In 2003, Marcia received a special commendation from then-Lt. Governor M. Jodi Rell as one of the "Outstanding Women of Connecticut" for excellence in medicine and dedication to women's health care and awareness. Marcia was listed as a Top Doctor by Castle Connolly from the review's inception until she retired. Marcia served on the Tri-State Board of the American Heart Association and many other community boards.

Marcia retired to Paradise Valley, Montana in 2004 with her late husband A. Bliss McCrum. Their tremendous philanthropic work in Park County has impacted organizations such as the Shane Lalani Center for the Arts, the Livingston schools, the Livingston Food Resource Center, and the Park County Community Foundation, among many others.

Marcia has been a supporter of Livingston HealthCare Foundation for many years; she joined the Board in July 2019.

This unit provides a powerful massaging action that transmits heat and tactile stimulation to achieve physiological and therapeutic benefits for hand, wrist, foot and ankle patients.

NXSTEP UNWEIGHING SYSTEM

The NxStep offloads a percentage of the patient's body weight allowing patients to begin rehabilitation earlier in an environment that is safe and secure for both patient and therapist. It can be used to treat patients who have experienced stroke, amputations, orthopedic injuries, or are living with Parkinson's Disease.

STRYKER STRETCHER

With an internal scale and X-ray cassette platform, this stretcher allows for in-room portable X-ray without repositioning the patient.

PEDIATRIC AND ADOLESCENT MENTAL HEALTH

Ranger Clinic Renovation

YOUR SUPPORT BRINGS RESOURCES AND SOLUTIONS FOR CHILDREN STRUGGLING WITH MENTAL HEALTH

By the Fall of 2018, it was evident that Park County was experiencing a behavioral health crisis. The number of reports of suicide and suicide ideation, including those among children, were staggering. Many agencies and individuals across the community came together to identify resources and solutions for people struggling with mental health.

Livingston HealthCare had been operating the Ranger Clinic at Park High for several years. Paula Coleman, Pediatric Nurse Practitioner, used a shared locker room space within the school to see student-patients mainly for primary care, sports injuries and other physical health needs.

In early 2019, LHC partnered with the Livingston School District to conceptualize an expansion of the Ranger Clinic that would allow for Coleman and a Clinical Psychologist to treat patients within the school setting, collaborating with the school nurse and administrators to address both the physical and increasing mental health needs of students.

Research shows that providing health care services within schools reduces transportation and other barriers to accessing care. It also limits the amount of missed classroom time and work hours for students and their parents, respectively, when traveling to health care appointments. Providing counseling and mental health services within the school also reduces the stigma of seeking help for mental health.

With the support of a generous grant from AMB West Philanthropies, along with contributions from so many in the community, the Foundation raised enough money to relocate and renovate the Ranger Clinic and to hire a Clinical Psychologist to work at both the Ranger Clinic and LHC's Clinic.

Construction on the new Ranger Clinic was completed in May 2020. Coleman and the newly-hired Christopher Spromberg, Psy.D. will begin seeing patients in the new space at the start of the 2020-2021 school year.

PHILANTHROPY AWARD

2020 RECIPIENTS: BETTY AND WHITNEY MACMILLAN

Bestowed by the Livingston HealthCare Foundation, the **Debbie Erdman-Lee Freeman Leadership in Philanthropy Award** is given in recognition of those who have made transformational contributions toward improving the welfare of citizens and the quality of life in Montana.

Recognition this year is awarded to Betty and Whitney MacMillan for their most generous donation of \$500,000 as the imprimatur to the establishment of an Endowment Fund to support Livingston HealthCare. The security of an endowment will help to perpetuate the hospital's high-quality service for generations of our community to come. Endowment donations are invested, and a portion of the annual income from the investments can be used to address immediate needs of the hospital.

The WEM Foundation was founded by Whitney and Betty in 1988. Since then, the WEM Foundation has donated millions of dollars to hundreds of charities and non-profit organizations supporting areas of Education, Agriculture and Conservation, Literacy, Arts & Culture, History and Health Care.

After graduating in 1951 from Yale University, Whitney joined Cargill as a general trainee, beginning what would be a 44-year career and a remarkable era of growth and diversification at one of the largest privately-owned companies in the world. Whitney was the last member of the Cargill-MacMillan family to

serve as CEO. He traveled to every corner of the globe to expand the business from 31 countries to 53. Under Whitney's leadership, the company grew from \$10B to \$33B in annual sales.

As with his and Betty's many philanthropic endeavors, Whitney was ever mindful of the power of industry and commerce to improve quality of life, a purpose-driven pursuit to make food a force for good.

After Cargill, Whitney continued to pursue his personal interests in international agricultural policy, world hunger and economic growth in developing countries. Whitney taught international business strategy and was an advisor to universities and government agencies on public policy matters concerning food safety, environmental and development issues. Whitney served on an extensive list of boards and was an active member of a diversity of educational and cultural institutions.

Betty and Whitney are known for their intellectual curiosity and shared a passion for travel, traversing the globe and visiting all seven continents. They "operated at one speed and that was full-speed ahead", according to WEM Foundation President, Jim Hield.

Betty MacMillan was born Elizabeth Sutton in Minneapolis. Betty and Whitney were high-school sweethearts. After Betty attended Briarcliff College in New York, they were married in 1952. According to close friends, Corky and Vanessa Brittan, "Betty was born cosmopolitan and epitomizes a woman's intuition."

Whitney had a "dynamic partner in Betty, she contributed in so many ways to his work and their philanthropy," says Jim.

Betty has served as a community leader in the Minneapolis area and at the national level. In addition to co-founding and leading the WEM Foundation for decades, she is a former member of the Smithsonian's National Board, American Art Museum and National Museum of American History, the Board and Executive Committee of the Minnesota Historical Society, and was co-owner of the NFL Football team the Minnesota Vikings.

Betty and Whitney spent many memorable times alone or with family and friends at their Wild Eagle Ranch in Sweet Grass County. Betty and Whitney have been generous supporters of the Museum of the Rockies in Bozeman, providing an endowment in honor of renowned paleontologist Jack Horner and his discoveries of the largest collection of dinosaur remains that fill the museum.

In addition to their support of the New Hospital Capital Campaign and the Endowment Fund, Whitney and Betty made a generous donation in gratitude to the medical staff for the care he received while a patient for a brief period at Livingston HealthCare. Sadly, Whitney passed in March at the age of 90.

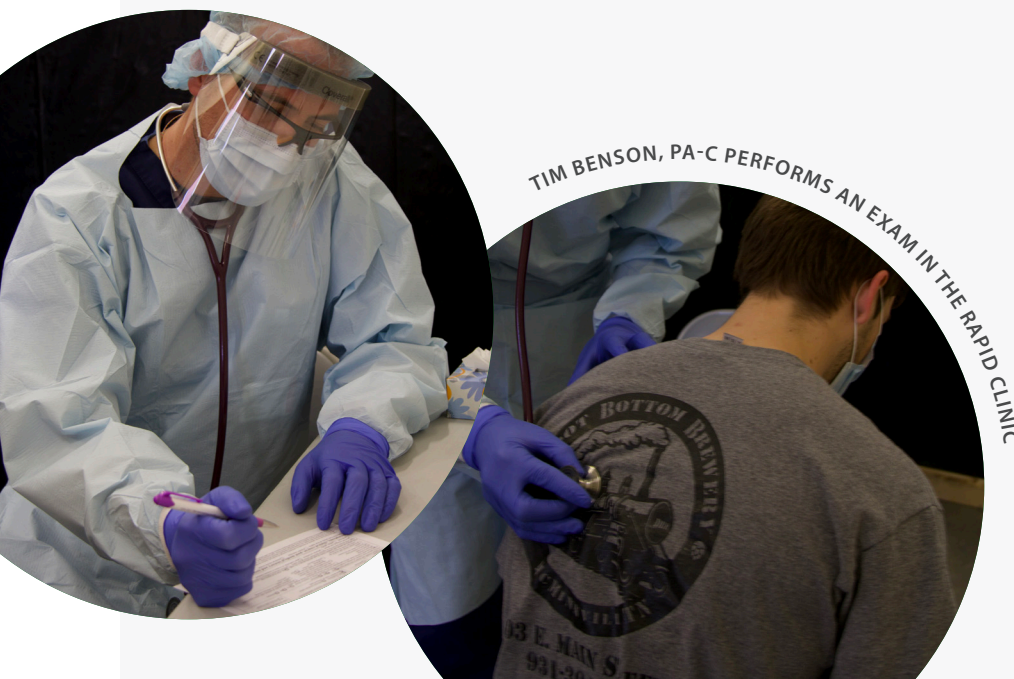

EMERGENCY RESPONSE FUND

The Foundation established an Emergency Response Fund to support LHC's immediate response to devastating events like the fast-moving global spread of COVID-19. Gifts to the Emergency Response Fund continue to be used to address the needs of patients and caregivers impacted by COVID-19 and to support emerging areas of greatest need.

Practically overnight, the team converted the ambulance bay into a Rapid Clinic to perform COVID-19 testing and, as of June 30, had performed 1,152 tests.

Similarly, Clinic staff shifted their focus from onsite primary care to Telehealth, conducting over 1,000 Telehealth visits between April 1 and June 30. As call volumes surged, many nurses were redeployed to manage a COVID hotline. Pharmacy staff compounded hand sanitizer in-house as a result of nation-wide shortages.

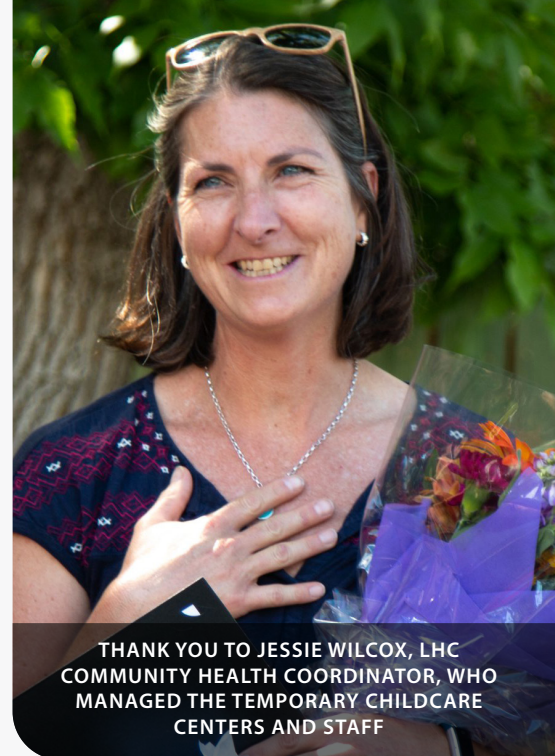
TEMPORARY CHILDCARE FOR FAMILIES OF LHC WORKERS

As the largest employer in Park County, LHC is especially aware of its contribution to the local economy and, at the start of the COVID-19 crisis, made a commitment to preserving all jobs at the medical facility. The large majority of LHC employees cannot afford not to work; their wages help to or solely provide for their families.

With the closure of public schools beginning March 18 and the temporary closure of childcare facilities, many LHC employees faced an impossible challenge. In an effort to support its staff, LHC made a fast decision to convert a rented house (used for travelers and locums during normal business operations) into a childcare center to provide free childcare for employees. The first location opened March 25 and immediately reached capacity, so project leaders quickly stood up two additional sites.

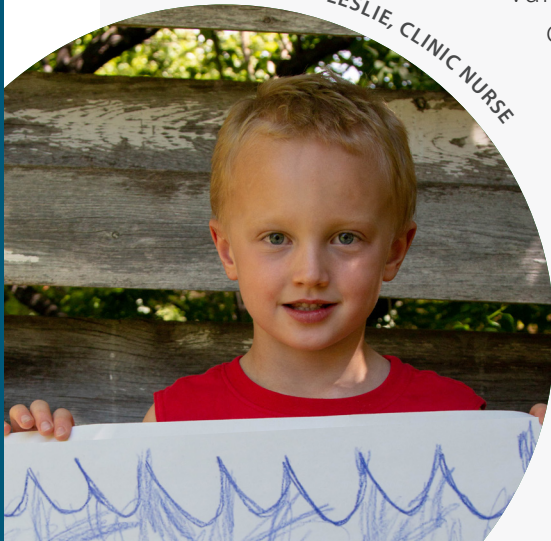
A total of 24 children received care at the three daycare centers with LHC staff rotating to operate the service. The centers remained open until camps and childcare facilities began summer programming.
